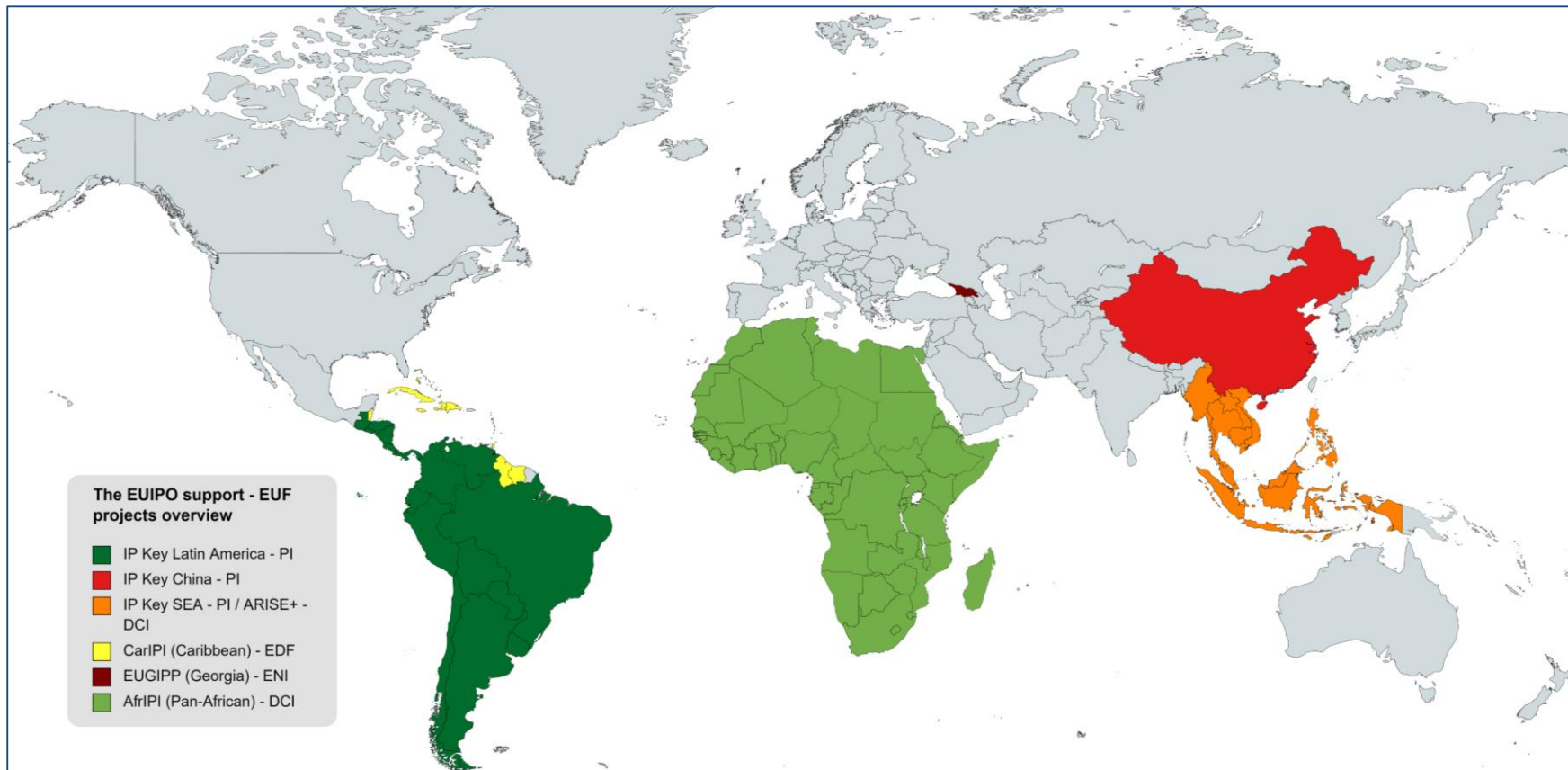

Specific Objective: To contribute to an adequate and effective level of protection and enforcement of intellectual property rights in Georgia according to the commitments of the AA/DCFTA.

Expected Results:

- I. Technical Cooperation: Strengthened IP institutions, networks, and IP related staff, for a more efficient and user-friendly IPR system.
- II. Enforcement cooperation: Contributed to the modernization, transparency and fair implementation of IP enforcement policies in Georgia.

Global trade mark search

TMview is a completely free to use pre-clearance tool, available online with daily updated information on trade marks from participating IP offices

DESIGN|view

Your key to registered designs search

DesignView is a search tool that centralizes information about registered designs from the databases of the participating IP offices

- ❖ **Smart navigation**
- ❖ **Fully multilingual platform**

The one-stop classification tool

TMclass is an online tool that helps users correctly classify goods and services when filing a trade mark

The online search tool for harmonised product indications

DesignClass is a set of user-friendly features that can help users find product indications in the Harmonised Database that best match the goods to which a design applies.

- ❖ **The Harmonised product indications database follows the same structure of classes and subclasses as the Locarno Classification.**
- ❖ **Locarno product indications and many more accepted by the participating IP offices**
- ❖ **Tree structure to facilitate users and examiners to find the correct product indication(s).**
- ❖ **Available in 28 languages**

FrontOffice

Fast, easy and efficient, with step-by-step guidance through the application process

- ❖ **Highly configurable, with sections and fields adaptable to the needs of each Office**
- ❖ **Pre-defined e-filing forms: trade mark application, design application, renewal, transfer of ownership, opposition... plus, the possibility of easily creating new ones**
- ❖ **Interfaces available to connect to different platforms including: applicants and representatives databases; payment platforms; classification; and products indications**

Benefits for Users

- ✓ Online availability 24/7
- ✓ Application is validated before submission so users are assured it is admissible
- ✓ Implemented by more than 20 IP offices, same user experience when filing in different IP offices

Benefits for IP Offices

- ✓ Perform formality checks at the moment it interacts with a user filing an application for a trade mark or design
- ✓ Save time and costs because of increased automated processes
