Concept: The 2023 EU4Digital Innovation Forum will bring together key policy makers and other experts who are engaged in supporting the digitalisation of SMEs and start-ups in the Eastern Partnership (EaP) region. It will provide a platform to share best practices and discuss challenges and ways forward for the digital upskilling of EaP businesses.

The first EU4Digital Innovation Forum was held on 27th of January 2022. The topic was ‘Innovative solutions for the development of start-up ecosystems in the Eastern Partnership’. The event culminated with the launch of the **Eastern Partnership Startups ecosystem** platform (eapstartups.co), which now supports the integration of the region’s start-up ecosystem into the EU Digital Single Market.

Objectives of the event:

1. Increase awareness of EU policies in the area of digital skills for SMEs and start-ups as well as relevant programmes and initiatives implemented by the EU and international donors;
2. Present the forthcoming EdTech Hub educational programme for enhancement of digital competencies in the Eastern partner countries;
3. Facilitate discussions on potential international cooperation and future needs.

- Ministerial level representatives and agencies coordinating the development of the innovation ecosystem;
- Innovation and SME support agencies;

Deputy Head of Unit, DG NEAR C1, European Commission

Nicholas Cendrowicz is the deputy Head of Unit in DG NEAR.C1 of the European Commission – the unit dealing with Moldova and Georgia, but also some of the regional aspects of the Eastern Partnership. He has over 25 years of experience in the European Commission, mostly in foreign relations (particularly with enlargement and neighbourhood policy), as well as connectivity. He was previously the deputy Head of Unit for Regional Co-operation in the Western Balkans, overseeing the expansion of this policy to become a cornerstone of our relations with this region. He was also the head of the Centre for Thematic Expertise on connectivity, environment and regional development in DG NEAR.

Before this, Nicholas worked in the Serbia and also the Kosovo team in DG Enlargement, having joined from the Romania team when Romania and Bulgaria acceded to the EU. In 2008, he was instrumental in organising a donors conference for Kosovo that collected over €1,4 billion in pledges.

Nicholas is also a long-standing expert on energy policy, particularly energy having worked on this file in the Commission's Energy department. He was the EU facilitator for the Kosovo-Serbia dialogue on both energy and telecommunications matters.

Nicholas has a degree in politics from the University of Bristol and a further degree in political science from the Institut d'Etudes Politiques in Paris.
